### ITEM # 2 - APPROVAL OF DECEMBER 9, 2023 MINUTES

### ITEM #3 - APPROVAL OF AUTHORIZING RESOLUTION

Mr. Becher and Mr. McCarthy explained the Authorizing Resolution provides permission to move forward with the Bond Sale. Mr. Becher and Mr. McCarthy explained the approval of the contract of purchase gives permission to take the bonds to market for resale. Mr. McCarthy further explained that Raymond James has standard documents that are completed at the end for him to buy from us and sell to another. After some discussion Mr. Gilroy requested a motion for the Contract of Purchase. A motion was made by Mr. Nelson to approve the contract seconded by Mr. Ford. *Vote: (4) Ayes. (0) Nays. (0) Abstentions.* Motion Carried.

## ITEM # 7 - APPROVAL OF SEQR NEGATIVE DECLARATION

Mr. Becher discussed the SEQR process with the members. Mr. Becher stated there is no environmental impact. After some discussion Mr. Gilroy requested a motion to approve the SEQR Negative Declaration. A motion was made by Mr. Nelson, seconded by Mr. Linder. Vote: (4) Ayes. (0) Nays. (0) Abstentions. Motion Carried.

#### ITEM # 9 - NEW BUSINESS

Ms. Murray suggest the Board vote on the election of officers since it hadn't been done since 2017. After some discussion Mr. Gilroy requested a motion to approve to have him continue as Chairman, Eric Linder as Vice Chairman, and elect Mitch Ford as the new Treasurer replacing Mr. Silberlicht. A motion was made by Mr. Nelson seconded by Mr. Ford. Vote: (4) Ayes. (0) Nays. (0) Abstentions. Motion Carried.
